KENNETH N. WAGNER, CHFM

Kenneth (Ken) Wagner is currently a Joint Commission Life Safety Code Surveyor and has been with The Joint Commission since January 2011. Prior to joining The Joint Commission full time, Mr. Wagner had over 42 consecutive years of experience in healthcare, 39 of which were in healthcare facilities management. He has served as facilities manager/facilities director at five different locations in the Pittsburgh, Pennsylvania area, most recently with Heritage Valley Health System where he was responsible for a 361-bed acute care and behavior health hospital, a 186-bed acute care and behavior health hospital, and approximately 100 ancillary sites.

Mr. Wagner was awarded the American Society for Healthcare Engineering (ASHE) Emerging Regional Leader award in 2011 and participated in the ASHE Leadership Institute in 2011 and 2012. He served on the board of directors of the Pennsylvania Society for Health Facilities Engineering (PSHFE) for 15 years, with two terms as president. He is a Certified Healthcare Facilities Manager and a Lean/Six Sigma Black Belt.

BILL KOFFEL

Bill Koffel is President of Koffel Associates, a fire protection and life safety engineering design and consulting firm, recognized as an expert in the fire protection and life safety aspects of codes and standards. Headquartered in the Baltimore-Washington metropolitan area, the firm provides consulting; engineering design and construction administration; codes and standards development; seminar development and training; product testing and evaluation / representation; and litigation support to public and private clients worldwide. Bill remains active in the development process of the industry's governing codes, standards and design guidelines including International Code Council (ICC), NFPA, Society of Fire Protection Engineers (SFPE) and Underwriters Laboratory (UL). A former code official with the Maryland State Fire Marshal's Office, he is a Past President of the SFPE.

SAMANTHA SEALOVER

Samantha Sealover is a registered fire protection engineer with Koffel Associates. She has six years of experience providing consulting for healthcare facilities throughout the USA and internationally. Her work experience includes performing life safety assessments, risk assessments, plans review, construction administration services, and general Life Safety Code and Building Code consulting.

Shannon Bunsen is Sustainability Project Manager at Mazzetti, and Executive Director of Sextant Foundation, a sustainable development non-profit that works in limited-resource and post-disaster settings around the world. Rachael has brought together engineering with energy and sustainability expertise, to manage energy consumption for a substantial return on investment at Children's Hospital of Philadelphia.

AL NEUNER

Al Neuner is Vice President, Facilities & Operations at Geisinger Health System. He is a native of Nazareth, Pennsylvania, received his mechanical engineering degree from Drexel University and worked for several years in the steel and air separation industries. In 1988 he joined the facilities operations staff of the Geisinger Health System, an integrated health system with facilities dispersed across a 31-county service area in central and northeastern Pennsylvania. As Vice President for Facilities Operations, Al is responsible for over 300 employees servicing a physical plant of over 10 million square feet. The main campus in Danville realized a significant energy savings because Al and his staff devised a creative strategy to manage energy resources, which resulted in a 40% reduction in overall energy consumption per square foot, including chilled water storage, cogeneration, and LEED commitment. Most recently, the site scored a perfect 100 on EPA's Energy Star.

Al has won many awards for his achievements. He received the prestigious 2002 FAME Award of Excellence from the Association of Facilities Engineers for his work on legionella remediation, the Chesapeake Bay Foundation awarded him the 2000 Businesses for the Bay Award for large business for pollution prevention and energy reduction, and the 2012 Donald M. Sauerman Award for Outstanding Contributions to the Field of Health Facility Engineering

NORMAN J. ZIEMER, PE, CHFM

Norman has over 40 years of balanced experience in facility maintenance, operations, and construction. The last 22 years have been in healthcare and he is presently the Director, Facilities Management at Indiana Regional Medical Center, Indiana, PA.
